Job Title	Prosthetist – Stanmore
Job Purpose/Summary	To provide and promote a high standard of Prosthetic care and treatment across a range of amputation levels, ensuring best practice, as part of a multi-disciplinary team. To ensure that all patients are afforded the highest standard of care within the resources available, maintaining respect, dignity and confidentiality for patients' individual needs at all times. To assist the Branch Manager in the day to day running of the prosthetic business.

To prioritise workflow to effectively meet deadlines. - To attend and participate in postgraduate training courses arranged by the company or local centre.

- To identify, in conjunction with clinical lead, and undertake any training requirements to ensure 'best practice' and personal development.
- To be aware of and meet the needs of clinical governance and BAPO Codes of Practice.
